Sir,

I am to say that the Board of Trustees in its meeting held on 17-11-2011 decided to make amendment of Para 33 (a) (iii) and insertion of Form No. 4 A in the ATPPF and P.F. and D.L.I. Scheme so that remittances of benefits to the beneficiaries can be made through individual bank A/C of beneficiaries.

Accordingly, the Govt, of Assam vide Notification No. GLR(RC)116/2012/10-A, dated 27/11/2012 (copy enclosed) has amended the ATPPF and P.F. Scheme.

Henceforth, all claims of P.F. settlements shall be paid through the individual bank A/C of the payees . As such, it is mandatory; to mention Name of Bank, Branch, Branch £FS Code and Bank A/C No. against every claimant in the requisition statement . The employers will obtain an advance stamped receipt in Form No.4 (A) (Specimen enclosed) and furnish the same along with requisition statement to the respective Zonal/Inspectorate Office of the Board of Trustees .

This will come in to force with immediate effect.

DATED DISPUR, THE 27th NOVEMBER, 2012

No. GLR(RC) 116/2012/10: In exercise of the powers conferred by Section 3(1) read with Section 5 of the Assam Tea Plantations Provident Fund & Pension Fund & Deposit Linked Insurance Fund Scheme Act, 1955, (Assam Act X of 1955), the Governor of Assam is hereby pleased to make the following Schemes further amend the Assam Tea Plantations Provident Fund & Pension Fund and Deposit Linked Insurance Fund Scheme, 1968, hereinafter referred to as the Principal Scheme, namely

Short title, Commencement and application 1.(1) This Scheme may be called the Assam Tea Plantations Provident Fund and Pension Fund and Deposit Linked Insurance Fund (Amendment) Scheme, 2012.

(3) It shall apply to all the employees in the Tea Plantations/Factories in Assam as defined in the Act.

(4) It shall come in to force on the date of their publication in the official Gazette.
Amendment of Para 2. In the Principal Scheme, in Paragraph 33, in 33(a)(iii) sub paragraph (a) for clause (iii) the following shall be substituted, namely

(iii) "If the collection of contribution of the current wage period is inadequate to meet the amount to be repaid to the members at a time, the Chairman of the Primary Committee may report to the Board with full details of the payees after obtaining Advance Stamped Receipt in Form No.4A. The Chairman of the Board of Trustees shall then forward the required amount into the respective Bank A/C of the payees with an intimation to the Chairman of the Primary Committee, who shall record such remittance in relevant Column of Form No. 1 Insertion of a new 3. In the Principal Scheme, after Form No.4 and Form No.4A . before Form No.5 the following new Form No.4A shall be substituted, namely:-
