ASSAM TEA EMPLOYEES PROVIDENT FUND ORGANIZATION Expression of Interest on Appointment of Receiver

Fresh Expression of Interest (EOI) are now invited from interested parties having sufficient administrative and financial capabilities to take custody and to manage the property of Kamini Tea Estate situated in the District of Dibrugarh on Lease for a initial period of 5 years and renewable for a further period. The period of such custody and management will terminate upon the subsequent sale by A.T.E.P.F. Organization of the Tea Estates due notice of which will be provided to the Prospective Receiver.

Terms and Condition:-

- 1)** Prospective Receiver has to deposit the Certificate amount of **Rs. 99,80,298.76** within **45** (Forty-five) days from the date of appointment of the Receivership.
- 2)** In addition to the certificate dues, Prospective Receiver shall have to deposit the arrear P.F. dues for the period from 16-03-1997 to 11-09-1999, 10-10-1999 to 17-06-2000, 03-09-2006 to 31-03-2007, 17-07-2011 to 01-07-2012 which could not be assessed due to non-submission of A/C .
- 3)** The interested bidders shall have to deposit 2% of the Certificate amount along with the Expression of Interest (EOI) as earnest money.
- 4)** The T.E. shall be taken possession of 'as is what is as basis' and 'as is where is as basis'.
- 5)** Annual Lease Rent at per K.G rate of Green Leaves to be produced annually to be quoted by the Bidder for the year **2017-18** after meeting all statutory and other expenses. The aforesaid Lease rent will be adjusted against the Certificate dues and other statutory liabilities.
- 6)** Intending Bidders are required to deposit the earnest money stated above by way of pay Order/Demand Draft payable at Guwahati and favouring A.T.E.P.F. Organization, Basistha, Lalmati, Guwahati - 29. The said deposit shall be adjusted in the case of successful bidder, otherwise will be refunded within a week of finalization of tenders. The earnest money will not carry any interest.
- 7)** The Offer/EOI along with the aforesaid Earnest Money Deposit should be made in a sealed cover superscribed "**Offer/EOI for receivership of Kamini Tea Estate**" so as to reach the Office of Recovery Officer, ATEPFO, Dibrugarh Zonal Office, Milan Nagar(K-lane), P.O. CR Building, Dibrugarh(Assam) on or before **28th February by 5.00P.M.**

8) Successful bidder shall have to deposit statutory interest @15% on the certificate dues till actual deposit of certificate amount and other statutory dues as per the terms mentioned in the agreement to be executed by the successful bidder with the ATEPFO Authority.

9) The Intending Bidders, desirous of spot inspection of the Tea Estate, should contact the Undersigned Officer, A.T.E.P.F. Organization, Dibrugarh Zonal Office, Milan Nagar(K-lane), P.O. CR Building, Dibrugarh(Assam) during Office hours from 21st February 2017 to 27th February 2017.

10) The undersigned is not bound to accept the highest offer on any or all offers and reserves the right to accept or reject any or all the tenders without assigning any reasons thereof.

11) In case all the tenders are rejected the undersigned can negotiate with any of the tenders or other parties for receivership of the Tea Estate by private treaty.

12) The successful Bidder would be required to execute and register an agreement with the A.T.E.P.F.O Authority and shall bear the changes such as stamp duty, registration fee, etc as applicable as per law.
