Chairman Board of Trustees (A.T.E.P.F.O.) is pleased to sanction for payment of ex-gratia to all the employees of Board of Trustees (A.T.E.P.F.O.) under following criteria:-

- A) Ex-gratia will be paid to the employees whose name appeared in the pay Bill of August'2016.
- B) All the regular employees except those who have not completed one year of service will be allowed to draw ex-gratia subject to maximum of Rs.11,000/- and minimum of Rs.7,100/-


Considering the aspect, it is suggested that ex-gratia for the current year may be paid in the following manner :

- (1) Grade -IV employees (G/Pay Rs.1,500/- to Rs.2,200/-)::
55% of Basic Pay, subject to minimum of Rs.7,100/- & maximum of Rs.7,700/-
- (2) Other employees (G/Pay Rs.2,400/- & above)::
- (I) Basic Pay up to Rs.15,000/-
50% of Basic Pay, subject to minimum of Rs.7,100/- & maximum of Rs.7,700/-
- (II) Basic Pay Rs.15,000/- to Rs.20,000/-
45% of Basic Pay, subject to minimum of Rs.7,700/- & maximum of Rs.9,300/-
- (III) Basic Pay Rs.20,000/- & above
40% of Basic Pay, subject to minimum of Rs.9,300/- & maximum of Rs.11,000/-
- (3) The contingency Menial who have completed one(1) year of service are allowed to draw a lump sum amount of Rs.2,400/-
